The Supplier is not liable for any direct, indirect, incidental, punitive or special damages. Using the Fonts is on your own risk.

In case of a breach of the obligations arising from this EULA, it terminates your license and rights to use the Fonts. This EULA is governed by the laws of the Czech Republic.
